- Responsible for the safe operation of a 1st class steam plant, >3000 e3m3/d sour gas processing with stabilization unit, deep cut, sulphur plant, and all associated utilities.
- Responsible for isolation and permitting activities in a large industrial setting.
- Must meet the requirements of ABSA and ASME codes as required.
- Must maintain an Operator log and operate the site’s power boilers in compliance with the regulations.
- Must follow and apply the site’s safe work procedures.
- Must be prepared to respond to an emergency and follow the site’s emergency response plan.
